Sub:- Plight of Sri Subrata Kumar Mukherjee, EIS No. 0330 Retd S.O.M., Sodepur Area, in receiving reimbursement for accidental treatment of his Spouse Smt. Shibani Mukherjee, vide Medical Card No. ECL/C-5(D)/ CPRMSE/Admn/02/99/0010 dated 23/03/2010.

Dear Sir,

In the few following paragraphs, we do hereby submit the details of plight being suffered by our member Sri Subrata Kumar Mukherjee, EIS No. 0330, Retd. S.O.M., Sodepur Area in receiving reimbursement for accidental treatment of his Spouse Smt. Shibani Mukherjee, vide Medical Card No. ECL/C-5(D)/ CPRMSE/Admn/02/99/0010 dated 23/03/2010.

Spouse of Mr. Mukherjee met an accident 2 years ago, and she was admitted in nearby non-empanelled Hospital, Starling Hospital, Asansol by her neighbours due to acute emergency. Mr. Mukherjee was not present in his house at the time of occurrence of his wife's accident. Her operation was done by Dr. K.B. Ghosh, Arthopaedic Surgeon of that Hospital.

Later on, as per provisions allowed under Section 3.2.1.(a).(ii) Sri Mukherjee submitted an application dated 17/09/2018 to the Chairman-cum-Managing Director, ECL enclosing therewith all original related papers, cash memos etc. to CMD, ECL for claiming a reimbursement of Rs. 83,452.00. This was done as per this referred provision which allows payments to be released on case to case basis on obtaining approval of Dir. (P&IR), CIL or CMDs of the subsidiary companies as the case may be.

It is regretted that even after a lapse of 18 months, the approval has not been received apparently due to negligence and lacklustre attitude of various departments involved in the process. The file movement of papers so far are as summarized below:-

- (i) From CMD Sectt. to D(F)/CMS dated 5/10/2018 docketed in the Register of CMS Dept. vide No. 5340 dated 06/10/2018.
- (ii) From D(F)/CMS to Officer In-charge, CPRMSE Dept. on 30/10/2018. docketed in the Register (Docket No. 733 dated 06/11/2018)

Thus, it is seen that first of all CPRMSE sectt. delayed the docketing for a week and after this, has taken no action in the past 15 months to clear the files/bills. As Mr. Mukherjee is a septuagenarian person, he cannot follow up his case frequently, and as a result his case is still pending after 18 months. Seeing his plight, office bearers of our Asansol Branch had ventured to meet Officer In-charge of CPRMSE / Sr. Manager(P/ EE) on 18.3.2020. Unfortunately he was unavailable in his chamber for attending another important jobs. Now the papers are lying with the CPRMSE Dept.

Now the papers are lying with the CPRMSE Dept. And it seems they are least bothered to wind this case up.

Under the circumstances, we are compelled to draw your attention so that due reimbursements to Sri Mukherjee is released at the earliest.
