Sub - Request for filing Counter Affidavit in WP No.11700/2022 on the issue of Payment of Performance Related Pay (PRP) to SCCL executives for the period Jan 2007 to FY 2013-14

Dear Sir,

Some of the Retired executives of SCCL have filed a writ petition for Payment of PRP from 2007-08 to 2013-14. SCCL Board has already approved ratings for each financial year basing on the CIL guidelines and performance of SCCL.

SCCL as a first respondent has filed Counter affidavit on 18.7.2022 and Government of Telangana has also filed Counter affidavit as a 2nd respondent.

The counter affidavit on behalf of Union Government (3rd respondent) is still awaited, for which, it is requested to expedite filing of Counter against the writ petition in Telangana High Court, Hyderabad.

In this context, the following points are brought to your kind notice for filing Counter Affidavit in Telangana High Court at Hyderabad.

- 1) The CIL and SCCL executives are covered under 2nd PRC for central public sector undertaking effective from 1/1/2007 to 31/12/2026. In this pay revision of CPSU executives, the provision for Performance Related Pay (PRP) was made which is to be paid at variable rates to executives on the basis of performance of the Organisation and as well as individual performance of the executives concerned.
- 2) The Singareni Collieries Company Limited, a joint venture of Govt of Telangana and Govt of India with 51% shares of Telangana state and 49% Shares of Union Government. The Singareni Collieries Company Limited is following Coal India Ltd in toto in respect of Executives service conditions, Pay Scales etc. after approval of SCCL Board.
- 3) SCCL Board approved pay scales similar lines of Coal India Limited and implemented with effect from 01.01.2007 vide circular no. CRP/PER/C/16/1214 dt.15.05.2009.
- 4) With regards to PRP, CIL issued Guidelines for implementation of Performance Related Pay (PRP) vide letter no. CIL/C5A(PC)/738 dt.18.11.2015. Even SCCL has provided Funds in their books of accounts for this purpose.
- 5) SCCL sent a letter to Government of Telangana vide letter No. CRP/CPP/MOU/694 dt.15.06.2016 for approval of Consolidated performance Ratings for the year 2007-08 to 2014-15.
- 6) Prior to Formation of Telangana state, SCCL sent letters to the then Government of Andhra Pradesh with regard to Draft MOUs also vide letter no. CRP/CPP/MOU2010-11/2656 dt.4.12.2013 and also vide letter no. CRP/CPP/PRP/789 dt.27.5.2014.

7) Government of Telangana has approved Ratings from 1.4.2014 onwards leaving the period from 2007-08 to 2013-14. From that time onwards PRP is continuously being Paid to Executives for on roll and Retired executives as per the guidelines implemented by CIL basing on performance of SCCL. For want of Government clearance, this amount for the period from 2007-08 to 2013-14 has not been paid. However, PRP amount from 2014-15 onwards is being paid to Executives without any interruption

It is requested to expedite filing of Counter affidavit against the writ petition in Telangana High Court, Hyderabad.
