- i. I had suffered from a Cerebral-Stroke on 16<sup>th</sup> March 2021 and underwent intense medical treatment at INK Hospital Kolkata from 16<sup>th</sup> March 21 to 1<sup>st</sup> April 2021 (Annexure 'A').
- ii. However, I joined the office w.e.f  $1^{st}$  July 2021after getting medical advice (Annexure 'B')
- iii. As per the provision of CIL, I had been granted Special Leave of 02 months with competent approval(Annexure 'C')
- iv. Further to the above, I had regularly been attending the office duty thereafter in the year 2021-22 with no leave without pay had incurred during my sickness.
- v. Now in the PRP calculation details, (attached Annexure `D') I have observed that in the year 2021 sanctioned special medical leave has not been taken into consideration as such of which my PRP calculation has not regulated according causing substantial financial loss to me at an stage when I have had to manage lots of allied expenses with the medical expenses at my own



"Clause 10(8)(xii) of 2017 pay revision guidelines states that "To be eligible for PRP concerned executive should have worked for a minimum period of 3 months in a financial year. The PRP benefit will be limited to only pro-rata basis for executives who are on AUTHORIZED LEAVE / ABSENCE for more than 3 months. "There is no ambiguity in the extant provision, hence it is felt that no clarification /interpretation is required. If any point is felt to be vague or unclear, it may please be indicated."


