But this new format has not been included in Annexure-I of CPRMSE Rules. Consequently, the Finance deptt. Of CMPDI is not accepting this new format Medical card for processing of claims for reimbursement under CPRMSE rules.

Retired executives are not aware of this stand of CMPDI Finance deptt and are puzzled when their claims are returned after several weeks pending in concerned department.

Really, it is nothing hut harassment of retirees, and the matter could have been easily sorted out by competent approval. If these new format cards are not being recognized by our own company persons, how one can accept that these will be honored by various empanelled hospitals.

Under the circumstances, it is requested that necessary instructions may kindly be issued for accepting New Format Medical Cards by Finance and other concerned departments.
