Dear Sir,

We had been raising our voice demanding various reforms in CPRMSE rules e.g. letter nos. AIACE/CENTRAL/2023/10 dated 22.2.2023, AIACE/CENTRAL/2023/25 dated 18.5.2023, AIACE/CENTRAL/2023/45 dated 18.7.2023, AIACE/CENTRAL/2023 / 102 dated 28.11.2023 and other letters in the past.

One of the demands raised by us was to include empanelment of NABH/NABL Accredited Laboratories & Diagnostic/Imaging Centres as such imaging and diagnostic procedures form an essential part of undergoing any medical treatment. In absence of such empanelment, CPRMS beneficiaries are being deprived of cost coverage towards such imaging and diagnostic procedures.

We welcome the decision of CIL for empanelling Laboratories & Diagnostic/Imaging Centres which have been empaneled for a period of three years w.e.f. 06.12.2023. (vide Annexure-I)

However, it is regretted that this empanelment is limited to Kolkata city only and seems to hammer a step-motherly treatment to other beneficiaries, who reside outside Kolkata at various places across this huge nation.

As such, we demand a comprehensive list of similar NABH/NABL Accredited Laboratories & Diagnostic/Imaging Centres across different places in line with the List of Empaneled Hospitals in circulation by CIL.
